The Anishinabek Nation Political Office has been very busy during the months of March, April, and May. There are several areas that I would like to highlight.

I have been appointed as the Chair of the Ontario First Nation Housing Steering Committee. The Committee is mandated to protect and maintain Aboriginal and Treaty Rights to housing, provide technical and political advice, recommendations and strategies to the Regional Chief, Chiefs of Ontario Political Confederacy and Chiefs-in-Assembly on all matters pertaining to First Nations housing related issues. I have served on the Committee for the past six years and I look forward to continue working on the Committee as the Chair.

I enjoy working on behalf of Anishinabek First Nations. I have attended several Restoration of Jurisdiction Chief and Council Information sessions in recent months. It has been gratifying to see momentum developing in the education negotiations. It is important that we continue the momentum that we have achieved in the self-government negotiations.

I have attended sessions and had the opportunity to present feedback at sessions related to First Nations Representation on Ontario Juries. The Debwewin Jury Roll Implementation Committee is looking at the jury questionnaire and areas to improve the questionnaire. The most recent meeting occurred on March 3 and I presented several recommendations at this meeting.
