WHEREAS the federal and provincial government have a contractual relationship through such agreements as the 1965 Indian Welfare Agreement, for the provision of provincial services and programs to Indians on the basis that the needs in First Nations should be comparable to standards applicable in other communities; and

WHEREAS the Anishinabek Chiefs in Assembly passed Resolution 2003/22 to direct the Union of Ontario Indians to ensure that the provisions in the provincial Child and Family Services Act related to Indian people are adhered to and adequately funded; and

WHEREAS that the Union of Ontario Indians began the process of restoring Anishinabek child welfare laws and codes that respect and promote Anishinabek world views.

THEREFORE BE IT RESOLVED that the Anishinabek Chiefs in Assembly direct the Union of Ontario Indians to continue the process of restoring Anishinabek Nation child welfare laws and codes; and

BE IT FURTHER RESOLVED that the Anishinabek Chiefs in Assembly direct the Grand Council Chief to establish a Roundtable with Canada and Ontario to improve the existing system of child welfare and youth services programs for Anishinabek First Nations by developing and confirming coordinated approaches to agreed-upon issues; and

BE IT FURTHER RESOLVED that the Anishinabek Chiefs in Assembly direct the Grand Council Chief to advocate that the federal and provincial governments provide financial resources for this process; and

WHEREAS this action has implications for B'saanibamaadsiwin's continuing ability to deliver holistic, culturally appropriate services to the First Nations and Aboriginal communities; and

WHEREAS this action comprises B'saanibamaadsiwin's ownership and operation of the program.

THEREFORE BE IT RESOLVED that the Anishinabek Chiefs in Assembly support B'saanibamaadsiwin's efforts to re-establish program funding to a separate agreement with the Ministry of Health and Long-Term Care; and

WHEREAS the Eshkeniijig/Youth Advisory Council received a mandate from the First Nations youth at the Eshkeniijig/Youth Gathering to support individuals who are affected by residential schools, to ensure on-going communication with First Nations, to incorporate the Grandfather teaching of respect in developing economic stability of First Nations, to promote language, and to advocate for post secondary funding; and

WHEREAS the Eshkeniijig/Youth Advisory Council will support the "Wedokdodwin", and Nation building of the Anishinabek Nation and work towards the inclusion and resolution of issues of the Eshkeniijig/Youth.

THEREFORE BE IT RESOLVED that the Anishinabek Chiefs in Assembly accept the duly elected members of the Eshkeniijig/Youth Advisory Council; and

BE IT FURTHER RESOLVED that the Anishinabek Chiefs in Assembly direct the Union of Ontario Indians to work with the federal and provincial governments to establish a fair and equitable process to support Anishinabek First Nation access to policing services; and

WHEREAS the Anishinabek Chiefs in Assembly acknowledge and commend the Ontario First Nation Police Commission, its staff and its Commissioners, for the role they have played in the development of First Nation policing; and

WHEREAS the Anishinabek Chiefs in Assembly recognize the need to build upon the work of the Ontario First Nation Police Commission and move forward in establishing a new civilian oversight body for First Nation police services.

THEREFORE BE IT RESOLVED that the Anishinabek Chiefs in Assembly direct the Union of Ontario Indians to work with the federal and provincial governments to support the development of a new civilian oversight body that meets the needs of Anishinabek First Nations and their membership; and

WHEREAS, in April 2003 First Nations and Inuit Health Branch ("FNIHB") implemented reporting requirements in the Medical Transportation Program that required First Nations to give personal client information, to address concerns raised by the Auditor General; and

WHEREAS, in the 2003/2004 contribution agreements for medical transportation FNHIB allowed for aggregate data to meet the reporting requirements. However in 2004/2005 medical transportation contribution agreements from FNHIB has stated that personal client data is a mandatory reporting requirement.

THEREFORE BE IT RESOLVED that the Anishinabek Chiefs in Assembly direct FNHIB to withdraw the mandatory reporting requirements until an independent legal analysis is conducted on the privacy concerns raised by First Nations; and

THEREFORE BE IT FINALLY RESOVLED that any First Nation Privacy Code developed shall supersede any Federal (Non Insured Health Benefits) or Provincial (Bill 31) Privacy Code.

BE IT FINALLY RESOLVED that the Anishinabek Chiefs in Assembly direct the Union of Ontario Indians to report and seek further approval at future Anishinabek Nation assemblies on the development of a national First Nation housing strategy and an Anishinabek Nation housing strategy as it progresses.
