- reflects a cooperative strategic approach to our rights based agenda;
- looks at governance, economy and treaty rights from a territory wide perspective; and

FURTHER BE IT RESOLVED that this revised strategic plan include mechanisms to evaluate our past and current challenges and to provide recommendations on how to move forward; and

FURTHER BE IT RESOLVED that this revised strategic plan look at implementation of priorities over the next ten years and include an evaluation framework based on tangible social indicators; and

FURTHER BE IT RESOLVED that this revised strategic plan include community-based participation in its development and implementation; and

BE IT FINALLY RESOLVED that the draft strategic plan be presented to the Chiefs in Assembly at the next Grand Council Assembly.

Subject: Anishinabek First Nation Band Employees' Entitlement to the Canada Pension Plan

WHEREAS the Canada Pension Plan Act was originally enacted in 1965 as part of the overall social safety net for the people of Canada and it required all employed individuals to contribute to the Canada Pension; and

WHEREAS from 1965 to 1988 the Canada Pension Plan Act specifically excluded First Nation Band employees from contributing to the Canada Pension Plan; and

WHEREAS in 1988 the Canada Pension Plan Act was amended to comply with the *Charter* to enable First Nation Band employees to elect to contribute to Canada Pension under certain conditions. However, First Nation bands were not provided with funding to enable them to make the employer contribution; and

WHEREAS many long term Anishinabek First Nation Band employees are now reaching retirement age and are not able to access the Canada Pension Plan which is held out by Canada to be an key component of Canada's social safety net for Canadian seniors; and

WHEREAS the Anishinabek Chiefs in Assembly are of the view that the Canada Pension Plan Act violates section 15 of the *Charter* which provides that each individual is equal before and under the law and has the right to equal benefit and protection of the law without discrimination based on race.

THEREFORE BE IT RESOLVED that the Anishinabek Chiefs in Assembly direct that the Grand Council Chief advocate, at the upcoming First Minister's Meeting and with the Minister responsible for the Canada Pension Plan, the need to resolve the outstanding grievances concerning First Nation Band employee entitlements to Canada Pension Plan retroactive to 1965; and

BE IT FINALLY RESOLVED that the Anishinabek Chiefs in Assembly direct the Assembly of First Nations to address nationally the need to resolve the outstanding grievances concerning First Nation Band employees' past entitlements to Canada Pension Plan.

Subject: Agenda for Restoring and Improving First Nations Health (formerly referred to as the Aboriginal Health Blueprint)

WHEREAS the Ontario First Nations Chiefs-in-Assembly carried Resolution 05/30 resolving to continue involvement in the process of engagement and development of a Health Blueprint, conditional upon alleviating nine (9) specific concerns; and

WHEREAS the Ontario First Nations Chiefs Resolution 05/30 stipulates "That any conditions identified through a careful legal review by a First Nations law firm must be met by external governments prior to the work being finalized" (condition number 7); and

WHEREAS such a legal review has not been conducted by the Chiefs Of Ontario; and

WHEREAS a legal opinion on the interests of the Anishinabek First Nations would involve a comprehensive analysis of the following: Anishinabek law, including Mnaamadzowin: a good way of life for the free and sovereign Anishinabek Nation; the Anishinabek traditional governance model, treaties and historical agreements signed by the Anishinabek; various federal and provincial government policies, transfer agreements and contribution agreements; and draft legislation regarding the establishment of LHINs – Local Health Integration Networks throughout Ontario to be introduced, on or before December 8, 2005; and

WHEREAS the political representatives and technicians of the Anishinabek Nation and the Anishinabek Health Commission have participated in the drafting of the Ontario Regional Submission – National Blueprint for Aboriginal Health FINAL – October 3, 2005, on behalf of the Anishinabek Nation and they report persistent resistance on the part of provincial officials to deviate from a pan-aboriginal approach; and uphold and advance the government to government relationship between First Nations and Ontario; and

WHEREAS the Anishinabek Chiefs-in-Assembly carried Resolution 2005/16 directing the Ontario Regional Chief to develop and implement a First Nations – Provincial Crown Political Accord ("*Accord*") on the Recognition and Implementation of First Nation's Health Governance in Ontario.

WHEREAS the Anishinabek Grand Council Chief denounced in writing to the Ontario Regional Chief the Ontario Regional Submission – National Blueprint for Aboriginal Health FINAL – October 3, 2005; and

THEREFORE BE IT RESOLVED the Ontario Regional Chief expedite the development of the *Accord* as contemplated in the *Accord* Resolution, 2005/16, following the development of and on the basis of the aforesaid legal analysis; and

WHEREAS the Anishinabek Chiefs in Assembly want to further coordinate resources, expertise and opportunities that may exist within the Intergovernmental Relations Forum.

THEREFORE BE IT RESOLVED that the Anishinabek Chiefs in Assembly hereby amend the wording of Resolution 2005/09 to specifically include health as an enumerated sector within the Gimaakinidizowin Resolution 2005/09; and

WHEREAS Anishinabek First Nations have managed the natural resources within their traditional territories since time immemorial and have never relinquished these rights and responsibilities; and

WHEREAS as part of the management of our traditional territories, Anishinabek First Nations have considered requests from First Nations people from other traditional and treaty territories to hunt and fish within their territory and, on occasion, have granted permission to these requests; and

WHEREAS numerous Anishinabek First Nation members are being charged under provincial law when exercising their aboriginal or treaty right to harvesting in other First Nation territories; and

WHEREAS Anishinabek Grand Council Resolution 2005/14, directed the Anishinabek Grand Council Chief to advocate for the Ontario government's recognition of Inter-Treaty harvesting; and

WHEREAS Anishinabek Grand Council Resolution 2005/14, directed the Government of Ontario to make change to the legislation and regulations that affect First Nations to exercise their rights; and

WHEREAS Anishinabek Grand Council Resolution 2005/14, directed the Anishinabek Nation Grand Council Chief to affirm the commitment of the Minister of Natural Resources regarding Inter-Treaty harvesting; and

WHEREAS the Ministry of Natural Resources' response has been unsatisfactory with regard to the recognition of our right to Inter-Treaty harvesting; and

WHEREAS the Anishinabek Grand Council Chief has made numerous attempts to have the Ontario government, as represented by the Minister of Natural Resources, recognize the Anishinabek First Nation's right to Inter-Treaty harvesting; and

WHEREAS the Chiefs in Assembly have expressed their support to move forward with a rights based test-case strategy; and

WHEREAS the Chiefs in Assembly have expressed a commitment to pool resources such as financial and/or administrative to support a rights based test-case strategy; and

THEREFORE BE IT RESOLVED that the Anishinabek Chiefs in Assembly direct that the Union of Ontario Indians develop a test case strategy in order to assert our treaty and aboriginal right to intertreaty harvesting. This strategy shall include but not limit to historical research and seek suitable test-case candidate and other relevant legal preparation that may be required; and

BE IT FINALLY RESOLVED that the Anishinabek Chiefs in Assembly direct that the Union of Ontario Indians report to the Chiefs in Assembly at the Next Grand Council Assembly on progress with respect to the strategy.

THEREFORE BE IT FURTHER RESOLVED that the Anishinabek Chiefs in Assembly request a full report on this matter as soon as possible.

SUBJECT: LOCAL HEALTH INTEGRATION NETWORKS (LHINs)

WHEREAS the Province of Ontario has expended extensive financial and human resources in the research, development and establishment of the fourteen (14) Local Health Integration Networks ("LHINs") throughout Ontario, since early 2003; and

WHEREAS the integration and devolution of health care services by the Province of Ontario will have profound adverse impacts on First Nations health and the existing First Nations health care jurisdiction; and

WHEREAS the First Nations were entirely disregarded until February, 2003 when the Ministry of Health and Long-Term Care invited First Nations technicians to an information session on the establishment of the LHINs; and

WHEREAS the Terms of Reference of the First Nations Task Force on the LHINs, as approved by the Ontario Chiefs Committee on Health in September, 2005, mandates the Task Force to submit a report to the Ministry of Health and Long Term Care (MOHLTC), on anticipated impacts of health service integration; and

WHEREAS the Province of Ontario is finalizing legislation for the establishment of LHINs with the intention of introducing it in the Legislative Assembly, on or before December 8, 2005; and

WHEREAS the Deputy Minister invited members of the First Nations Task Force to review and provide First Nations-specific feedback on the proposed LHINs legislation; on November 4, 2005; and

WHEREAS the Deputy Minister simultaneously invited First Nations PTOs, Aboriginal Health Care Service Providers and various other Aboriginal health organizations to review and provide feedback on the proposed LHIN legislation on November 7, 2005; and

WHEREAS the First Nations Task Force members and representatives of the First Nations PTO's advised the Deputy Minister to speak with the First Nations leadership; and

WHEREAS the Chiefs of Ontario prepared a number of draft legal recommendations that has been circulated to the First Nations Task Force on the LHINs and is under consideration by the PC of the Chiefs of Ontario; and

WHEREAS the nature and impact of the draft legal recommendations is not widely understood by the Anishinabek Nation and the Anishinabek Health Commission; and

WHEREAS the draft legal recommendations on the elements of the LHINs indicate that First Nation's jurisdictions could either be enhanced or diminished; and

WHEREAS throughout the establishment of the LHINs the rights and interests of the Anishinabek First Nations have not been considered or upheld, and are inconsistent with the Honour of the Crown in Right of the Government of Canada and the Honour of the Crown in Right of the Government of Ontario.

THEREFORE BE IT RESOLVED that the Anishinabek Chiefs in Assembly establish immediately a government to government roundtable forum with Premier McGuinty; Minister of Health Smitherman; Deputy Minister Sapsford, to discuss all issues inherent in the passing of provincial legislation regarding the LHINs (Local Health Integration Networks);

THEREFORE BE IT FURTHER RESOLVED that the Anishinabek Chiefs in Assembly hold a conference, as soon as possible, on the issue of Health jurisdiction, governance of the Anishinabek Nation's Health; Healing; and Wellness;

THEREFORE BE IT FURTHER RESOLVED that an invitation be extended to the Ontario Regional Chief to attend the conference.

BE IT FINALLY RESOLVED that discussions will be directed to the representatives of the Ontario Government that we the Anishinabek will be opposing the unilateral establishment and the enactment of the Local Health Integration Networks.

WHEREAS the Anishinabek Nation requests Indian and Northern Affairs Canada to release the education funds prior to or to coincide with the school board billing dates therefore eliminating late penalty and/or interest charges.

THEREFORE BE IT RESOLVED that we, the Chiefs of the Anishinabek Nation request that Indian and Northern Affairs Canada change the release date of educational funding to First Nations to occur prior to or to coincide with provincial school board billing dates; and

FURTHER BE IT FINALLY RESOLVED that any further late penalty and/or interest charges be covered by Indian and Northern Affairs Canada and that it is not the responsibility of the First Nations.
