Subject: Development of Position for Ratification of Self-Government Agreements

WHEREAS by Resolution 95/25 the Anishinabek Chiefs in Assembly directed the Union of Ontario Indians to enter into self-government negotiations with the federal government in all areas including, among others, governance, education, lands, resources, justice and social services; and

WHEREAS the Union of Ontario Indians have been involved in Governance and Education negotiations under the federal Inherent Right Policy since 1996, recognizing that twenty-eight First Nations have already approved the Agreement in Principle with respect to Education and twenty seven First Nations have approved the Agreement in Principle with respect to Governance, with more communities considering whether to enter into these agreements; and

WHEREAS the Education and Governance Self-government Final Agreements require ratification by each individual First Nation before they become effective in law; and

WHEREAS the current federal policy requirements for ratification of First Nation self-government agreements has produced unsuccessful results in numerous First Nations across Canada based on the fact that the approval threshold required by the federal government is significantly higher than similar processes implemented in other segments of Canada; and

WHEREAS the federal government has no legislated formula for approval thresholds in ratification processes for self-government agreements.

THEREFORE BE IT RESOLVED that the Anishinabek Chiefs in Assembly direct the Union of Ontario Indians to research current ratification and referendum processes within First Nation, provincial and federal governments within Canada and the United States and develop a ratification position for the self-government agreements to be presented to the Anishinabek Chiefs in Assembly in the fall of 2007.

WHEREAS Anishinabek First Nation jurisdiction regarding citizenship is a practice, custom, and tradition integral to our distinctive culture and as such it is an Aboriginal right; and

WHEREAS the United Nations International Covenant on Civil and Political Rights guarantees that all peoples have the right of self-determination. By virtue of that right they freely determine their political status and freely pursue their economic, social and cultural development; and

WHEREAS the determination of Indian status and membership arbitrarily set out in the Indian Act is contrary to the United Nations International Covenant on Civil and Political Rights of which Canada is a signatory to.

THEREFORE BE IT RESOLVED that we, the Chiefs in Assembly reject the Government of Canada's unilateral definition and control over the definition of "status Indian" and assert that our Aboriginal rights include jurisdiction of Anishinabek Nation citizenship, which rests solely with the Anishinabek Nation; and

FINALLY BE IT RESOLVED that the Anishinabek Chiefs in Assembly direct the Grand Council Chief to secure resources and prepare a draft citizenship law that could be used by member First Nations to determine their own citizenship in accordance with historical practice and in accordance with the rights guaranteed by the United Nations International Covenant on Civil and Political Rights.

WHEREAS the Aboriginal Healing & Wellness Strategy (AHWS) Phase III Implementation Agreement sunsets on March 31, 2009 and a renewal process is underway for Phase IV, which will be in effect on April 1, 2009; and

WHEREAS the Anishinabek Chiefs in Assembly fully support the vision of AHWS to foster improvements in the health and well-being of First Nations and other aboriginal individuals, families, communities and Nations, by addressing the limitations of existing services and programmes, and identifying, designing, and implementing culturally appropriate solutions; and

WHEREAS the Phase III Implementation Agreement, a consolidated agreement governed by a single entity, the Joint Management Committee (JMC), represents a pan-aboriginal approach to management and impedes effective delivery of services to First Nations citizens; and

WHEREAS Chiefs of Ontario Resolution 05/30 and Assembly of First Nations Resolution 04/104 have consistently denounced the pan-aboriginal approach and, furthermore, Chiefs of Ontario Resolution 06/16 demanded the establishment of a *First Nation/Ontario Health Accord*; and

WHEREAS it is necessary to safeguard our inherent and treaty rights, and ensure the federal and provincial governments' fiduciary obligations to provide health services to First Nations, and to ensure that they fulfill their duties to consult and accommodate First Nations; and

WHEREAS the third AHWS Implementation Agreement is currently being reviewed and evaluated, with the fourth phase of relationships currently in negotiation.

THEREFORE BE IT RESOLVED that we, the Chiefs in Assembly, hereby demand that the Government of Ontario through the Ministries that are signatories to the AHWS implementation agreements, respect First Nations' constitutionally recognized inherent and treaty rights through the formal establishment of a separate First Nations table, and a First Nations specific governing body to replace the homogeneous approach represented by the JMC structure; and

FURTHER BE IT RESOLVED that we, the Anishinabek Chiefs in Assembly, hereby mandate the Ontario Regional Chief and the Political Confederacy to explore the establishment of a First Nations AHWS governing entity within the current AHWS structure, to be explored in the First Nations/Ontario Health Accord, that will govern Phase IV for First Nations on a Government-to-Government basis; and

FURTHER BE IT RESOLVED that the Phase IV Implementation Agreement should encompass separate agreements for First Nations; and

WHEREAS we, the Anishinabek Chiefs in Assembly commend the Anishinabek Nation Youth for sharing their words with us, so that their recommendations will be central to our actions and decisions in bettering the lives of the Anishinabek.

THEREFORE BE IT RESOLVED that we, the Anishinabek Chiefs in Assembly, recommend that the Grand Council Chief meet with the Anishinabek Nation Youth to discuss specific issues that can be included in a joint work-plan to be action upon and include communicative aspects; and

THEREFORE BE IT FURTHER RESOLVED that we, the Anishinabek Chiefs in Assembly direct that the Grand Council Chief issue a policy statement stating how the Anishinabek will act to immediately incorporate and implement the direction received from the Anishinabek Nation Youth into the Anishinabek Nation and Union of Ontario Indians decision-making processes; and

THEREFORE BE IT FURTHER RESOLVED that we, the Anishinabek Chiefs in Assembly, direct the Grand Council Chief to lobby the Governments of Canada and Ontario to secure funding to develop a comprehensive Anishinabek Youth Strategy that shall include language, culture, recreation, economic, social, political, environment and an Anishinabek Nation Youth Summit in which senior level officials from the Anishinabek, Governments of Canada and Ontario are invited to attend and meet with our Anishinabek Nation Youth; and

Subject: Intergovernmental Relations Process

WHEREAS the All Ontario Chiefs Conference mandated the Chiefs of Ontario to revitalize the intergovernmental process through resolution 22/01; and

WHEREAS the governments of Canada and Ontario confirmed their commitment to the development of a new relationship through a government-to-government process; and

WHEREAS the three parties agreed to initiate intergovernmental discussions through a facilitated process that resulted in the *Revitalizing First Nations-Canada-Ontario Intergovernmental Relations Report* (the "Report"); and

WHEREAS the Political Confederacy accepted the Report and recommendations at Kenora in February 2005; and

WHEREAS Canada, Ontario and the First Nations, represented by the members of the Ontario Political Confederacy, met on June 10, 2005, to confirm the commitment of Canada and Ontario to act on the recommendations of the Report and the draft two-year work plan developed by the Senior Officials Forum; and

WHEREAS the two-year work plan expired on June 10, 2007; following which an evaluation of the intergovernmental process was completed by a consultant which was presented at the 2007 Chiefs of Ontario Assembly; and

WHEREAS the evaluation of the intergovernmental process found that although the working relationships between the parties have improved, there has been no enhancement of intergovernmental relations and no substantial progress on any one particular intergovernmental issue over the two-year period in support of First Nation priorities; and

WHEREAS due in part to a majority of First Nations in Ontario considering themselves as 'observers' rather than full participants in the intergovernmental process, many First Nations in Ontario have advocated for their own Nation-specific intergovernmental affairs processes.

THEREFORE BE IT RESOLVED that we, the Anishinabek Chiefs in Assembly, declare the mandate of the two-year work plan for intergovernmental process between Canada, Ontario and the First Nations to be completed and that no further action is necessary as currently structured; and

THEREFORE BE IT FURTHER RESOLVED that we, the Anishinabek Chiefs in Assembly, strongly express our disappointment with the failure of the intergovernmental process with Canada and Ontario and do hereby withdraw from that intergovernmental process as currently structured; and

THEREFORE BE IT FURTHER RESOLVED that we, the Anishinabek Chiefs in Assembly, direct the Grand Council Chief to advise the other parties in the intergovernmental process with Canada and Ontario that the Anishinabek Nation hereby withdraws from that process as currently structured; and

BE IT FINALLY RESOLVED that we, the Anishinabek Chiefs in Assembly, direct the Grand Council Chief to advocate for the development of an intergovernmental process that addresses the issues outlined in the evaluation and that is responsive to the priorities of Anishinabek First Nations.

This includes the proliferation and protection of these concepts to, and for Anishinaabe."; and

WHEREAS Enendamowin includes the Anishinaabemowin language, traditional knowledge and sacred teachings; and

WHEREAS the Anishinabek people have been educated using our Anishinaabemowin language, traditional knowledge and sacred teachings since time immemorial; and

WHEREAS Anishinabek First Nations continue to learn and use our Anishinaabemowin language, traditional knowledge and sacred teachings; and

WHEREAS the Union of Ontario Indians have been negotiating a Final Agreement on Education with the federal government on behalf of the Anishinabek Nation to restore our jurisdiction over education; and

WHEREAS our Anishinaabemowin language, traditional knowledge and sacred teachings will be a major part of our new Anishinabek Educational System; and

WHEREAS the principles of Enendamowin and traditional education, more often than not, must be taught in the traditional lodges, societies and institutions of the Anishinabek; and

WHEREAS regular gatherings such as ceremonies, teaching lodges and the Three Fires Confederacy Gathering are instrumental in the proliferation of Enendamowin; and

WHEREAS there are some schools, organizations and institutions in our territory that penalize students and employees who attend these gatherings by deducting wages and accrual of absentee days.

THEREFORE BE IT RESOLVED that the Anishinabek Nation Chiefs in Assembly support the teachings of Enendamowin, Anishinaabemowin language, traditional knowledge and sacred teachings;

BE IT FURTHER RESOLVED that the Anishinabek Nation Chiefs in Assembly hereby state that Enendamowin and principles of Anishinabek traditional education are as important as mainstream curriculum and professional development.

BE IT FURTHER RESOLVED that the Anishinabek Nation Chiefs in Assembly support all Anishinabek citizens to attend gatherings such as ceremonies, teaching lodges and the Three Fires Confederacy Gathering without penalty.

BE IT FINALLY RESOLVED that the Anishinabek Nation Chiefs in Assembly respect the autonomy of our First Nations and affiliated schools, organizations and institutions and respectfully encourage our respective personnel policies be amended to reflect these principles.

WHEREAS the Anishinabek Chiefs in Assembly have approved-in-principle the document entitled "Anishinabek Nation Matrimonial Real Property Law: Protecting our Families, Children and Communities Upon Marriage Breakdown and Protection of Land" as a framework law for facilitating the development of Anishinabek First Nation regulations respecting matrimonial real property subject to the amendments proposed during the March 23, 2007 Anishinabek Nation Special Assembly on Matrimonial Real Property.

THEREFORE BE IT RESOLVED that we, the Chiefs in Assembly approve the requested amendments made to the document "Anishinabek Nation Matrimonial Real Property Law: Protecting our Families, Children, Communities, and Land Upon Marriage Breakdown"; and

WHEREAS the Anishinabek Chiefs in Assembly passed Resolution 2006/26 directing the establishment of a First Nations Child and Family Services Secretariat to begin developing First Nation child welfare laws and codes; and

WHEREAS Resolution 2006/26 further directed the Grand Council Chief to lobby and meet with the Minister responsible for the Ministry of Children and Youth Services to confirm and establish working relationship between the Anishinabek Nation and the provincial and federal governments with adequate financial resources being made available; and

WHEREAS the Ministry of Child and Youth Services has indicated that it will respect the Constitutional section 35 right of First Nations to be consulted and accommodated on matters pertaining to First Nations; and

WHEREAS the government of Ontario has recently created a Ministry of Aboriginal Affairs to develop a stronger, broader partnership with Ontario's Aboriginal People in response to Justice Linden's recommendations in the Ipperwash Inquiry Report; and

WHEREAS the Anishinabek recently advocated for the Government of Canada to demonstrate its commitment to restore Anishinabek jurisdiction in child welfare, to which the Minister of Indian and Northern Affairs Canada has indicated his willingness to discuss this matter.

THEREFORE BE IT RESOLVED that we, the Anishinabek Chiefs in Assembly direct the Grand Council Chief to establish a coordinated and resourced tripartite process in which the governments of Canada and Ontario work together to ensure the restoration of Anishinabek jurisdiction in child welfare through the creation of a First Nations Child and Family Services Secretariat and Child and Family Court; and

BE IT FURTHER RESOLVED that we, the Anishinabek Chiefs in Assembly, demand that funding for these tripartite discussions, a component of which must include community consultations, be accessed through the New Relationship Fund recently created by the Government of Ontario to improve First Nation skills and resources to work more seamlessly with governments; and

BE IT FURTHER RESOLVED that we, the Anishinabek Chiefs in Assembly, direct the Union of Ontario Indians to develop an action plan to restore Anishinabek jurisdiction in child welfare through the implementation of Resolution 2006/26 to create a First Nations Child and Family Services Secretariat; and

WHEREAS with the elimination of the Band Representative positions, many First Nations do not have the appropriate resources and capacity to respond to the Ministry of Child and Youth Services when matters concerning children are brought to their attention or when they are asked to respond to and participate in consultations.

THEREFORE BE IT RESOLVED that we, the Anishinabek Chiefs in Assembly, endorse the Grand Council Chief to lobby the governments of Canada and Ontario to establish a trilateral process to develop a new approach and initiative which consists of adequate program policies, adequate funding, and capacity development of First Nations to respond to and protect the rights and interests of Anishinabek children when taken into custody, apprehended, placed in Crown wardship, placed for adoption, or requested to participate in consultations; and

THEREFORE BE IT FINALLY RESOLVED that we, the Anishinabek Chiefs in Assembly, recommend that this trilateral process be formally incorporated into the First Nations Child and Family Services Secretariat, once established.
