MOTION (1): Chief Norman Agounie, Sheguiandah Chief Paul Goulais, Nipissing

THAT the Agenda be adopted as proposed.

MOTION (2): Chief Ron Wakegijig, Wikwemikong Chief Wilmer Noganosh, Magnetawan

THAT the Motions of the Board of Directors'

Meeting held September 15, 1975 be adopted.

MOTION (3): Chief Ron Boissoneau, Garden River Chief Charles Shawkence, Kettle Point

WHEREAS the 54 Chiefs of the Union of Ontario

Indians recognize the need for continued funding

of the organization known as the Union of Ontario Indians and its' meetings;

BE IT THEREFORE RESOLVED that the Indian Community Secretariat of the Ministry of Culture and Recreation of the Ontario Government, both for this meeting of September 16, 17 and 18, 1975 and for all future meetings, provide a level of funding that would represent fairly the proportion of the Chiefs' time that is spent discussing matters relating to Native problems and interests of a Provincial nature.

THAT the ballots be destroyed.

MOTION (9): Chief Leo Nicholas, Muncey of the Thames Chief Carl Johnson, Caldwell

THAT the Union of Ontario Indians' Chiefs adopt the Resolution regarding the D Program Circulars, as formulated by the Resolutions Committee.

CARRIED.

The Resolution reads as follows:

WHEREAS the Chiefs of the Union of Ontario

Indians recognize the need for sincere and
businesslike consultations between the Department

of Indian Affairs and the Indian people;

AND WHEREAS we recognize the inadequacies of present legislation and procedures to deal with the administrative needs of our band organizations:

AND WHEREAS the Government of Canada has been conducting a program of unilateral implementation of its' policies;

We, the Chiefs of the Union of Ontario Indians, categorically reject the Department of Indian Affairs' Program Circulars D-1 through D-5. We also reject all other Guidelines issued by the Government without full and proper consultation.

There has been no such consultation with our bands. We agree with the principle of accountability for all Government-source funding.

We wish to create our own financial and administrative procedure and accounting.

We demand full Federal funding to carry out the necessary meetings for this purpose.

We demand that these deliberations and subsequent meetings and negotiations be conducted with the full knowledge of the Union of Ontario Indians and all the Chiefs and Councillors and not, as has been

the case, with bands individually, as this latter course has only been divisive and counter-productive.

We demand a halt to the holding back of quarterly funding by the Government as a lever for acceptance of the Guidelines. This is blackmail and is an unfair form of taking advantage of poor people and poor bands. We condemn this type of action, and direct the release of all funding that is being held back as a result of these guidelines and the Government's policy.

We do not wish any bands, both the smaller bands and the larger ones, to be hurt by Government policy in this area.

#### (MOTION 10): Chief Ron Boissoneau, Garden River Chief Norm Stinson, Rama

THAT we, the Chiefs of the Union of Ontario

Indians agree that in the event that the

Department of Indian Affairs does not take proper
and immediate action on our Motion (9) dated

September 17, 1975 with respect to the Policy

Guidelines, the Chiefs of the Union of Ontario

Indians will close all reserve Administration
Offices in our area, and freeze all documents in
those offices and in our possession, until such
time as the Department reaches agreement with our
organization and bands on the above-mentioned
Motion on the principle of consultation and on
policy matters.

MOTION (11): Joe Michano, Heron Bay

THAT the discussions regarding the closing down
of Band Administration Offices be held in-camera.

# MOTION (12): Franklin Shawbedees, Saugeen Chief Paul Goulais, Nipissing

THAT the authority be vested in the President and the Vice-Presidents of the Union of Ontario Indians to determine the date when the Indian reserve Administration Offices shall be closed and for how long.

In protest to the policies and tactics of the Government, as referred to in the previous Motion,

the President shall first attempt to receive agreement from the Department of Indian Affairs to the proposals in the Motion.

# MOTION (13): Chief Frank Solomon, Cape Croker Chief Margaret Jones, Shawanaga

CARRIED.

WHEREAS deplorable conditions continue to exist on our reserves because of the Department of Indian Affairs' policies;

AND WHEREAS the Department has consistently ignored the wishes and voices of the Indian people;

AND WHEREAS the Department has misused and abused its' trust responsibility over our lands and monies;

NOW THEREFORE, we, the Chiefs of the Union of Ontario Indians demand a full public inquiry with Indian people participating on the Board of Inquiry, to investigate all activities, spending and responsibility of the Department of Indian Affairs across Canada, and also that this Board of Inquiry have full access to all documents in the

possession of the Government or elsewhere, and also that the results of this Inquiry be made public.

#### UNANIMOUSLY CARRIED.

MOTION (14): Larry Johnson, Caldwell

THAT the Union of Ontario Indians accept the
Resolution drawn up by Mrs. Rosamond McCue with
regard to the Education Circulars.

CARRIED.

The Resolution reads as follows:

WHEREAS Program Circular E-12, The University and Professional Educational Assistance Program - Policy and Administrative Guidelines has been given Treasury Board approval prior to consultation and against the wishes of the elected members of the Union of Ontario Indians. This rejection was officially voiced in the form of Band Council Resolutions. This indicates that the opinions and decisions of the Chiefs and Band Councils have been undermined and can be easily ignored by the Department of Indian Affairs. This is completely unacceptable;

AND WHEREAS Program Circular E-12 has already been given Treasury Board approval; any consultation at this point would be mere tokenism and of absolutely no value;

THEREFORE, the Chiefs of Ontario hereby unanimously resolve to inform the Minister of the Department of Indian Affairs and Northern Development, Mr. Judd Buchanan, that we categorically reject Program Circular E-12. It is not to be implemented in any way, shape or form, now or ever;

WE FURTHER RESOLVE that the former policy of educational assistance be continued. It will only be changed when the Chiefs and Band Councils deem it necessary. When, and if, this happens, the direction for change will come from the Chief and Band Council of that particular reserve in consultation with the affected students of that same reserve;

WE FURTHER RESOLVE that, in the event that the Program Circular E-12 is implemented against our wishes, we will:

1. Close our Band Offices and not allow any Indian Affairs' personnel to set foot on Indian land. 2. Call for a full and intensive parliamentary investigation of the dealings and the way in which Indian people have been involved in doing business with the Department of Indian Affairs.

THAT a joint Department of Indian Affairs and

Union of Ontario Indians committee be established

to assist the bands of the Union of Ontario

Indians in establishing the necessary procedures
for accountability of Federal funds; and

FURTHER, that the membership of this committee be
as follows:

2 representatives from the D.I.A. Regional Office, as determined by the Regional Director; and 2 or more representatives from the Union of Ontario Indians as chosen by the U.O.I. Board of Directors;

AND FURTHER, that all costs incurred for this purpose be underwritten by Regional Office; and THAT funding should not be withheld while this process is underway.

## MOTION (19): Chief Norm Stinson, Rama Franklin Shawbedees, Saugeen

WHEREAS the Chiefs of the Union of Ontario

Indians feel that the Department of Indian

Affairs has not truly represented the Indians of

Ontario by way of the Minister of Indian Affairs

not giving the Chiefs and Band Councils of Ontario

the opportunity of expressing their wishes before signing the policing agreement with the Ontario Solicitor General;

AND WHEREAS the Federal-Provincial agreement respecting Indian policing of Ontario Indian reserves does not express the needs of the Chiefs and Band Councils of Ontario;

NOW THEREFORE the Chiefs of the Union of Ontario
Indians demand that amendments be negotiated and
be made to the agreement between the Provincial
and Federal Governments respecting Indian
policing of Ontario Indian reserves in order that
the agreement will truly express the needs of the
Chiefs and Band Councils of Ontario.

MOTION (20): Murray Whetung, Curve Lake Chief Leo Nicholas, Muncey of the Thames

THAT the present Department of Indian Affairs'

Subsidy Housing Program not be phased out by the next fiscal year, but rather be improved to meet the demand of the backlog housing needs for the Indian communities of Ontario.

THAT the position of the Resource and Information Specialist be stabilized.

MOTION (22): Chief Ron Boissoneau, Garden River Chief Norm Stinson, Rama

THAT the Union of Ontario Indians send Gary
Miller, Resource and Information Specialist, and
also one delegate from each Ontario Indian
organization, to British Columbia for possibly
one month in order to study their current
situation; and also

THAT a delegation from B.C. be requested to come to Ontario in order that they may speak to all of the bands and explain their situation more clearly.
