THAT, we, the Chiefs of the Union of Ontario Indians, as Chiefs of the Ojibway, Ottawa, Pottawatomi, Muncey and Algonquin Nations, state that:

We must have full and equal involvement at all stages and all levels of the negotiations to revise the Constitution of Canada.

If this is not forthcoming, then we shall state that the kind of limited participation that is being offered is not acceptable; that we will not participate at all under these conditions; that we want to make it clear that decisions made without Indian participation will not be considered to affect Indians at all, and will not be binding on Indians; that nothing will be done that will affect Indian people and Indian Nations without their consent and participation;

We shall then state that we want Canada to set its own constitutional house in order first, before we will begin direct negotiations with Canada on the subject of the relationship between the Indian Nations and Canada.

We shall also proceed to make our concerns known in the international forum, to gain the support of other Nations, and to gain their recognition of our Rights.

THAT we, the Chiefs of the Union of Ontario Indians, support the Presentation made to the Minister of the Department of Indian Affairs, by the people of the Gull Bay Band: <u>Emergency Gull Bay Band Evacuation</u> Eight days ago, because of a major forest fire threatening our Reserve, over 300 members of Gull Bay Indian Reserve had to evacuate to Thunder Bay, with just the clothes on their backs.

Up to now, the only assistance that the Department of Indian Affairs and Northern Development has offered our people, was partial advance payment of welfare cheques <u>only</u> to those persons now receiving General Welfare Assistance.

This situation is causing serious hardships to our people. Much, if not all of the people's personal savings and partial welfare cheques have been spent in providing food and clothing for their children.

Members of our Band are finding it difficult to handle the uncertain situation that faces them. It is not known how long we will have to remain away from our homes, or if we shall have homes to return to.

We are demanding that the DIAND take a much more positive role in helping us.

Emergency situations call for immediate action: We are expecting you, Mr. Minister, to make definite commitments in meeting the unexpected physical and financial hardships we are facing. Not only today, but tomorrow when we can clearly see the full extent of the damage done to our community.

WHEREAS the Department of Indian Affairs has been drastically reducing their man-years while at the same time increasing the workload to the Band level.

BE IT HEREBY RESOLVED THAT we, the Chiefs of the Union of Ontario Indians, direct the Honourable John Munro, Minister, Department of Indian Affairs and Northern Development, to ensure an immediate revision to the inadequate core and administrative funding levels to bring them in line with the current needs of Band Governments, and also to transfer the savings from the reduction of Department man-years to the Bands.

WHEREAS Ontario's Indian population is over 22% of the total Indian population in Canada; AND WHEREAS the Indian people in Ontario are no less needy than Indian people in other parts of the Country;

AND WHEREAS the Bands in Ontario receive a disproportionately small share of Federal program funds;

AND WHEREAS this situation has been repeatedly brought to the attention of the Government; WE THEREFORE RESOLVE THAT the Federal Government should immediately rectify this regional disparity in funding;

AND THAT the Minister of Indian Affairs and Northern Development should firmly and publicly commit himself to this action today.



- revision of the definitions for nondiscretionary activities;
- 4) making Bands fully aware of all ramififications of these data base forms before implementation;
- 5) provide an adequate period of time of two months from the current July 15th deadline to ensure Band involvement.

THEREFORE BE IT RESOLVED THAT all the Chiefs from the Union of Ontario Indians meeting, held in Sault Ste. Marie, July 1, 2, 3, 1980, demand that this Management Team be restructured to reflect the following membership and that the Chairmanship shall rotate from each meeting held: 4 members from the Department of Indian Affairs; 4 Indian organization representatives; 1 Canadian Executive Services Overseas representative.

WE FURTHER direct Roger Jones, Director of Economic Development, Union of Ontario Indians, to follow up on this Motion, and to report periodically to the Chiefs through regional meetings regarding progress on this issue.

- a) An improvement in opportunities for protective employment and access to those opportunities, and
- b) The sustainment of existing productive employment opportunities;

AND WHEREAS these communities require certain measures to realize their development potential in human and natural resources;

AND WHEREAS the objectives of the GDA reflect a commitment to encourage socio-economic development in those areas of Ontario requiring special initiatives to permit residents to contribute to and participate in the benefits of Economic Development;

AND WHEREAS the present Economic Development programs offered by both the Federal and Provincial Governments are indeed inadequate; AND WHEREAS the Indian communities realize that firm measures must be taken by both the Federal and Provincial Governments to support the socio-economic development of Indian communities;

NOW, THEREFORE, BE IT RESOLVED THAT "All the Union of Ontario Indians' Chiefs" in their meeting held in Sault Ste. Marie, July 1, 2, and 3, 1980, demand that the Federal and Provincial Governments take firm action immediately, and be given the responsibility for the following plan:

 a) To set up a Steering Committee made up of Ministers that would include the following Departments and Ministers: Department of Indian Affairs; Department of Regional Economic Expansion; Canada Manpower; Department of Public Works; Ministry of Natural Resources; Ministry of Industry and Tourism; Northern Affairs; and all Indian Organizations' Presidents;

- b) The Steering Committee shall have the responsibility of setting up and seeking the appropriate funding for a Working Committee and Task Force. The Working Committee shall consist of technical people from the organizations and Governments. The Task Force shall consist of mainly technical people from the grassroots level or Reserve communities;
- c) The Steering Committee shall be responsible to ensure that the Native needs already defined in the Proposal presented to the Chiefs by the Union of Ontario Indians Economic Development Committee be incorporated in various subsidiary agreements as well as further needs defined by the Task Group and Working Committee being set up;
- d) The mandate of the Working Committee is to restructure and change the policy and guidelines for the present Department of Indian Affairs Economic Development program with full Indian participation.

AND WHEREAS these positions must be developed and identified if the Bands of the Union of Ontario Indians are to have meaningful and full input into the Indian Act Revisions; THEREFORE BE IT RESOLVED THAT the Chiefs of the Union of Ontario Indians assembled here at the 1980 Union of Ontario Indians All Chiefs Assembly do hereby state that their participation in the Indian Act Revision process is a high priority and;

BE IT FURTHER RESOLVED THAT the Chiefs of the Union of Ontario Indians hereby direct the Minister of Indian Affairs to provide an adequate level of funding to the Union of Ontario Indians' Indian Act Liaison Program as determined by their yearly budget submissions and,

WE FURTHER DIRECT THAT this funding be provided immediately to the Union of Ontario Indians' Indian Act Liaison Program.

WHEREAS the Chiefs of the Union of Ontario Indians want changes to the present Social Services Delivery System under the 1965 Welfare Agreement;

AND WHEREAS the Findings Report entitled "A Starving Man Doesn't Argue" supports the need for change;

BE IT RESOLVED THAT we, the Chiefs of the Union of Ontario Indians, agree with the following:

- THAT the All Canada Chiefs Resolution establishes a political framework as Indian goals and values;
- THAT with this refined position on Indian goals and values only one alternative concept is established for an Indian Community controlled Social Services System;
- THAT this one alternative concept is a long range planning approach;
- THAT the principle goals and strategy of Bands would be to:
 - 1) Reaffirm Indian identify
 - 2) Exercise Indian authority
 - Secure recognition of Indian values and rights in the constitution.

These goals are the essential framework in expressing Indian aspirations for the future of Indians.

 - Self-Government

 - INDIAN DETERMINED to plan and develop services for Indians, by Indians;
 - 3) BAND CONTROLLED to manage services operations under the authority of Band Councils and Indian Band law;

 - a) in each community, or
 - b) in an Indian community.

THAT the Union of Ontario Indians Chiefs and Councillors support Serpent River Band Council in their request to the Department of Indian Affairs and Northern Development to place a priority on funds to reclamate the acid factory site at the Serpent River Indian Reserve.

THAT we, the Chiefs of the Union of Ontario Indians, will not participate in negotiations with the Provincial Government while our people are under intensive attack in the courts.

We want existing charges withdrawn or put off and a clear statement that, in the future, Indian people fishing for food for themselves, and other useful purposes, will not be charged;

We want a change in the regulations; the change should make clear that the regulations are subject to the terms of any Indian Treaty; We do not consider the Ministry of Natural Resources Minister's proposal of a permit system acceptable. It is neither right nor practical.

And that the above shall include Treaties, Surrenders, that are silent on their hunting and fishing rights.

RESOLVED as a Special Resolution, THAT:

- THAT the Corporation be and is hereby authorized to make application to the Lieutenant Governor of the Province of Ontario for the issue of Supplementary Letters Patent which revise the location of the Head Office and amend the provision relating to the election of directors by:
 - A) Changing the location of the Head
 Office the Corporation to be situated
 at Mississauga Indian Reserve #8,
 P.O. Box 1299, Blind River, Ontario
 POR 1B0.
 - B) Deleting the provision relating to the election and retirement.
- 2) The directors and officers are hereby authorized and directed to do, sign, and execute all things, deeds and documents necessary or desirable for the due carrying out of the foregoing.
