#### 1. EXECUTIVE VICE-PRESIDENT/DEPUTY GRAND CHIEF

The terms of office were reviewed by Joe Miskokomon. Chief Stinson recommended that the following be included: " that the duties/responsibilities may be amended from time to time."

Elder Miskokmon questioned as to whether or not this is a full-time position; and also what range in salary is being considered?

Joe clarified that the position is full-time; it is a political representative - there will be a split of duties between the Grand Council Chief and the Executive Vice-President. A Special Chiefs' Assembly will be called for mid-October; the purpose will be to hold an election for this position; the actual term of office will be for the remanding term of the present Grand Council Chief (18 months or so); then the two positions would run on a regular Grand Council electoral basis.

Chief Naponse questioned also questioned as to the salary level and where would the dollars come from?

Joe responded that the range of salary being considered is \$45,000 -- salary; with a \$15,000 travel budget. In terms of funding allocation; the Finance Committee would have to make room within the present budget allocations. Once a decision has been made regarding the office space and re-location; there would be some savings in the overall budget.

RESOLUTION # 1:

THAT we accept the terms of office for the Executive Vice-President/Deputy Grand Chief; with the amendment that the duties/responsibilities may be amended from time to time.

#### 2. CONSTITUTIONAL BY-LAWS OF THE ORGANIZATION

Joe proceeded to review recommended changes to the By-Laws of the Corporation, which were prepared by Czernik & White, for the inclusion of a Executive Vice-President/Deputy Grand Chief position. These are attached as Appendix B.

Elder Miskokomon expressed concern with respect to the term of office for this position; he suggested that for continuity, that a staggered term between the Grand Council Chief and the Executive V-P/Deputy Grand Chief be looked at.

Chief Hare recommended that the term of office be on a team basis; that they be elected together. He pointed out that on a staggered basis, there could be potential for division between the two positions.

By a show of hands, the Chiefs/Elders identified their preference: same term -- 26; staggered -- 1.

**RESOLUTION # 2:** 

THAT we accept the proposed amendments to the Union of Ontario Indians' Constitutional By-laws.

**RESOLUTION # 3:** 

THAT a Union of Ontario Indians' Special Chiefs' Assembly be held October 18, 1989 at Spanish River First Nation (Community Centre) in order to hold elections for the position of Executive Vice-President/ Deputy Grand Chief.

FURTHER THAT the term of office will be for the remainder of the present President/ Grand Council Chief's term.

MOVED BY: CHIEF LEONA NAHWEGAHBOW, Whitefish River SECONDED BY: CHIEF RENO DOKIS, Dokis

CARRIED.

#### 3. LEGAL DEFENSE

Peter Akiwenzie relayed a concern of Chief Roy Michano in regard to the required \$1,000.00 yearly contribution to the fund by First Nations; Chief Michano would like to see some consideration given to smaller First Nations paying less after the initial first year contribution because of the band support dollars they receive.

Chief Sarazin suggested that the amount be based on the On-Reserve population, rather than the total Reserve population.

Peter indicated that this is something the Review Board can deal with.

Chief Hare further suggested that \$1,000.00 be the minimum contribution by all First Nations; and that the larger First Nations contribute more.

Chief Nahwegahbow advised that there are some small First Nations who can afford to pay the \$1,000.00.

Peter recommended that any changes to the terms of reference can be brought through the Executive; and that they can also look at the amount of the contribution in relation to the smaller First Nations. He advised on a concern of Chief Sarazin; in that the lawyers who are advising the Review Board are also lawyers representing First Nations; this is very close to a conflict of interest. The Executive will need to clearly state the advisory services of the lawyers; they will also need to discuss the present situation involving LaForme Henderson (that being, Harry LaForme is now Commissioner of the ICO and Bill Henderson has moved to Blaney McMurtry).

## **RESOLUTION # 4:**

THAT we adopt the terms of reference for the Legal Defense Program, including the amendments proposed by the Executive.

MOVED BY: CHIEF VERNON ROOTE, Saugeen SECONDED BY: CHIEF CHRISTI PERVAIS, Fort William

CARRIED.

#### 4. ONTARIO NATIVE COUNCIL ON JUSTICE (ONCJ)

Bob Watts advised the Chiefs that the Union is still a member of ONCJ; and that commitment was stated at the ONCJ Annual Meeting. ONCJ is in the process of planning a policing symposium; they have been advised that this symposium should not be dealing with First Nation jurisdiction over First Nation policing.

Chief Pervais questioned as to how the Union of Ontario Indians' representative is appointed. She expressed concern on the lack of attendance to some meetings.

Joe advised that Henry Peltier had been the representative at one time; but unfortunately, was not able to attend many meetings. He further stated that the Union would participate when we can.

It was then agreed that the Union would advertise with the membership requesting a representative for ONCJ.

5. OFFICE SPACE - RELOCATION

Four proposals were received -- North Shore Tribal Council; Nipissing; Whitefish River; and Munsee-Delaware. The following resolution was made:

**RESOLUTION # 5:** 

THAT the Executive Council, along with the Secretary-Treasurer (Chief Norm Stinson) and an Elder (appointed by the Elders Council), review the proposals on office relocation that came forward from:

- 1. North Shore Tribal Council
- 2. Nipissing
- 3. Whitefish River
- 4. Munsee-Delaware; and,

that their recommendation(s) be distributed to all the First Nations prior to October 18, 1989 for ratification at the Union of Ontario Indians' Special Chiefs' Assembly, October 18, 1989.

# Appendix A

#### TERMS OF OFFICE

# TITLE:

Executive Vice-President/Deputy Grand Chief

# **REPORTING TO:**

Grand Council Chief, Chiefs-in-Assembly, Board of Directors and/or as designated in the By-Laws.

#### **RESPONSIBILITIES:**

- (a) To assure that staff in the program areas are working in accordance with resolutions;.
- (b) To act as an negotiator on behalf of the Anishinabek with the Federal and Provincial governments;
- (c) To consult with First Nations of the Anishinabek regarding local, regional and national issues;
- (d) To act as a lobbyist in the absence or at the direction of the Grand Council Chief;
- (e) To sit as a delegate of the Anishinabek on Planning and Priorities Committee of the Chiefs of Ontario;
- (f) To assume an active role on behalf of the Anishinabek with the Assembly of First Nations;
- (g) To divide responsibilities with the Grand Council Chief in dispute resolution structures;
- (h) To assume other duties as directed by the Grand Council Chief, the Chiefs-in-Assembly, the Board of Directors and/or as described in the Corporate By-Laws;
- (i) To act as a political representative on behalf of the Anishinabek.
