WHEREAS the Grand Council Chief has addressed this issue with the Minister of Community of Social Services; and,

WHEREAS the Minister has responded by planning a task force with Native representation to review the <u>Child and Family Services Act</u> and make recommendations for reform of policies and administrative arrangements; and,

WHEREAS this response is an interim remedy only and will not contribute to First Nation capacity for authority and jurisdiction over Child and Family Services:

WHEREAS only nineteen First Nations have accessed this funding and this distribution has, for some First Nations, not significantly contributed to improved employment conditions due to the very limited resources made available; and,

WHEREAS West Bay First Nation has asserted its jurisdiction and prohibited entry of MNR personnel by Band Council resolution 3126 (March 21. 1994) and reaffirmed with support from all Robinson-Huron Chiefs through resolution 94.2 (May 25, 1994); and,

WHEREAS the MNR has ignored the concerns of West Bay regarding an incident where Conservation Officers John Dieboldt and Ian Anderson drew their weapons unprovoked and repeated racial slurs to First Nation members as documented in R vs. Debaissiage, December 21, 1993:

THEREFORE BE IT RESOLVED THAT the Chiefs in Assembly support West Bay's assertion of their jurisdiction and demand that the MNR respond to all of the concerns brought forward by West Bay First Nation; and,

BE IT FINALLY RESOLVED THAT the U.O.I. Intergovernmental Affairs program initiate meetings with West Bay and other interested First Nations to develop long-term strategies and approaches to First Nation jurisdiction over resources to be discussed with the MNR.

WHEREAS one hundred and fifty (150) students have graduated throughout the years; and,

WHEREAS the First Peoples of Canada have an inherent right to hunt, fish and gather for personal, ceremonial, social, and barter purposes; and,

WHEREAS the Alderville. Beausoliel. Curve Lake. Georgina Island, Hiawatha, Rama and Scugog Island First Nations were party to the Williams Treaty with the intent to share some of the resources within their traditional territory; and,

WHEREAS these seven First Nations absolutely did not intend to alienate their basic and fundamental rights to resources which essentially includes the livelihoods and ways of life of the citizens of these First Nations; and,

WHEREAS, despite the Williams Treaty First Nations' perspective and intent, the Supreme Court of Canada ruled on May 12, 1994 that the citizens of these seven First Nations extinguished their right to resources; and,

WHEREAS the Anishinabek Chiefs support inalienable Aboriginal rights of all First Nation citizens to their traditional pursuits of hunting and fishing:

THEREFORE BE IT RESOLVED THAT the Chiefs in assembly reject the HOWARD decision of the Supreme Court of Canada regarding the Williams Treaty rendered on May 12, 1994; and,

BE IT FURTHER RESOLVED THAT the Chiefs in Assembly direct the Governments of Canada and Ontario to cooperate immediately with these seven First Nations to develop an interim agreement to accommodate their rights and needs; and,

Vernon Roote,

Deputy Grand Council Chief **BE IT FURTHER RESOLVED THAT**, as a long term solution, the Governments of Canada and Ontario must enter into negotiations with these seven First Nations to confirm the original spirit and intent of all past discussions and agreements with respect to the Williams Treaty; and,

BE TO FINALLY RESOLVED THAT the Chiefs in Assembly direct the Grand Council Chief to take all steps necessary and to work closely with these seven First Nations to ensure that the Governments of Canada and Ontario act immediately and effectively to ensure recognition of the inherent Aboriginal rights of these First Nations and to provide adequate interim measures.

Joseph Hare, Grand Council Chief **WHEREAS** there are two specific regional training institutes as well as the new Anishinabek Training Institute ready to coordinate and deliver health worker training:

THEREFORE BE IT RESOLVED THAT the Chiefs in Assembly direct the Health Director and Education Director to draw up a Terms of Reference for the health worker training needs under the new provincial funding and direct those training dollars to the Anishinabek Training Institute; and,
